Mentoring Project Excel is the Corporation's flagship mentoring program. This program focuses on mentoring to middle and high school African-American males to help them develop essential life skills, to improve their academic performance, and citizenship. Mentees are required to enroll in this program and commit to remaining in it for at least one year. Parents are also required to ensure that their sons are present for at least 80% of program activities. There were 66 participants in this program this year. Mentees who successfully participate in this program for at least three years and matriculate to a two- or four-year university become eligible for a Village Legacy Scholarship. Since its inception in 1994, hundreds of teenage males have participated in Project Excel and the Corporation has awarded over \$85,000 in Village Legacy Scholarships. This year \$5,000 of Village Legacy Scholarships were awarded to five different participants. This program also includes activities outside of school, such as picnics, field trips to see cultural and sporting events, and travel to and participation in selected National 100 Black Men of America conventions. Mentoring also includes a Summer STEM and Robotics Academy program that provides enrichment opportunities for students in the 5th through 8th grades interested in learning computer programming, robotics, video game development, and language arts.

**Health and Wellness** The Corporation's health and wellness goals are to raise awareness, provide access to health care and give health information that will ultimately promote behavior change resulting in a healthier lifestyle. The Corporation's primary health and wellness program is called *Wise Guys*. This program focuses on providing young males between the ages of 14 and 18 knowledge of positive communication techniques, healthy masculinity, sexual violence prevention, and teen pregnancy prevention. The *Wise Guys* program is a weekly, 10-session group intervention for adolescent males that is delivered by a staff educator. Each session is approximately 45 to 60 minutes long. This program is funded by a contract the Corporation has with the State of Louisiana's Department of Health and Hospitals. The Corporation is reimbursed under the contract based on the number and types of units of service provided. This year 128 students participated in the *Wise Guys* program. In addition to the *Wise Guys* program, the Corporation partners with local medical facilities to offer free health screenings for a myriad of health issues and encourages our community to become proactive in maintaining good health.

From qualified applicants, the executive director position was offered and accepted within the predetermined salary range. Several grants were proposed to other nonprofit organizations to fund the executive director position, disclosure of compensation amounts were made to these nonprofits, and grants were awarded to the 100 Black Men of Baton Rouge for this purpose. Every year, a Human Resource committee consisting of 4 board members evaluates the executive directors performance. Potential raises are considered based on a performance matrix developed by the committee. The committee also considers the reasonableness and competitiveness of the compensation structure compared to other non-profit organizations in the area.</p>
