THE HOMELESS RESOURCE CENTER IS A ONE-STOP HOMELESSNESS RESOURCE CENTER ORGANIZED FOR THE PURPOSE OF ASSISTING HOMELESS PERSONS AND FAMILIES WITH OBTAINING AN INCOME, PROVIDING A HYGIENE CENTER FOR PEOPLE EXPERIENCING HOMELESSNESS, AND MEETING SOME BASIC NEEDS OF HOMELESS INDIVIDUALS TO ASSIST THEM WITH SECURING INCOME AND HOUSING. THE CENTRAL LA COALITION TO PREVENT HOMELESSNESS, INC. IS THE CONTINUUM OF CARE FOR CENTRAL LOUISIANA. IN THIS ROLE, THE ORGANIZATION WORKS WITH LOCAL GOVERNMENT TO PROVIDE TRANSITIONAL AND PERMANENT HOUSING, AND IS ALSO RESPONSIBLE FOR CONDUCTING AN ANNUAL COUNT OF HOMELESS PERSONS WITHIN THE COMMUNITY, KNOWN AS THE POINT IN TIME STREET COUNT. Rapid Rehousing (RRH) is a program designed to quickly move families and individuals from homelessness into permanent housing by assisting with rental deposits, first month's rent, utility deposits, and limited rental assistance, as well as supportive services, to ensure housing stability.
