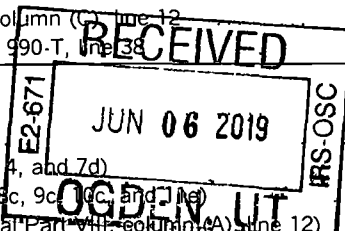

The CASA program provides recruitment, training, and supervision to volunteers who advocate for abused children as they navigate through the court system. The organization served approximately 550 children.

4b (Code) (Expenses \$ 597,957. including grants of \$) (Revenue \$)

The Children's Advocacy Program provides a safe environment where children who have disclosed sexual or severe physical abuse can be interviewed by a trained forensic interviewer. A multi-disciplinary team of professionals observes the interview via closed-circuit televisions while the child's statements are preserved by videotape for further investigation. Additionally, clinical services including individual, family, and group counseling are offered. This program conducted 738 forensic interviews and provided counseling hours totaling 490 to clients.

In 2018, the organization conducted over 600 presentations and training to prevent child abuse and neglect.
