AMENDED ARTICLES OF INCORPORATION
OF
VOA PROPERTY CORPORATION NWW
A NON-PROFIT CORPORATION

Pursuant to the Resolution of the Board of Directors of the Corporation, adopted at a duly constituted meeting held of September 20, 2013, at which a quorum was present and at least two-thirds of the Directors present voted in favor of the Resolution, the following Amended Articles of Incorporation are hereby adopted pursuant to Section 24.03.183, RCW.

I. The name of the Corporation is being changed to: ~~VOA WESTERN WASHINGTON~~
~~PROPERTIES~~, a nonprofit corporation. Its registered agent shall be Philip Smith,
President/CEO of Volunteers of America Western Washington, and the address of such
registered agent shall be 2802 Broadway, Everett, WA 98201.

II. The purposes for which the Corporation is formed are as follows:

(a) The general purpose shall be to engage in activities that are consistent with the laws of this state relative to non-profit corporations, with the charitable purpose of the Corporation or with Section 501(c)(3) of the Internal Revenue Code.

(b) The specific purpose of the Corporation is to operate exclusively for the benefit of and to support the purpose, functions and programs of Volunteers of America, Western Washington, a Washington non- Profit Corporation, or its successor. Included in this purpose is to purchase or otherwise acquire, hold, own, use and convey real property and to engage in other business activity permissible for a Section 501(c)(3) non- profit corporation, including to promote, support and administer charitable and educational activities of every kind and nature whatsoever in its own behalf or as the agent, trustee or representative of others if and to the

extent consistent with the foregoing purposes, and to aid, assist and support corporations, associations and foundations organized and operated exclusively for one or more purposes described in Section 501(c)(3) of the Internal Revenue Code and exempt from federal income taxes. For the foregoing, the Corporation shall have all powers afforded by the Revised Code of Washington – Washington Nonprofit Corporations Act. The sale, lease, exchange or other disposition of all, or substantially all, the property and assets of the Corporation in the usual and regular course of its business and the mortgage or pledge of any or all property and assets whether or not in the usual course of business may be made upon such terms and conditions and for such consideration, which may consist in whole or in part of money or property, real or personal, including shares, obligations, or other securities of any other corporation, domestic or foreign, as shall be authorized by its Board of Directors.

(c) This Corporation shall in no substantial part engage itself or focus its activities upon the carrying out of propaganda, or otherwise attempting to exert influence on legislation or legislators, nor shall this Corporation participate or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

III. This Corporation shall have no members, in accordance with RCW 24.03.065.

IV. This Corporation is being organized, and is organized, under the laws of the State of Washington. This Corporation is not being organized for pecuniary gain or profit of the directors or officers and is therefore being organized for non-profit purposes.

V. This Corporation shall have no capital stock, nor shall the individual property of the directors of this Corporation be liable for any debts of the Corporation.

VI. The existence of this Corporation is to be perpetual.

VII. The general management of the affairs and activities of this Corporation shall be, except as otherwise provided herein or in the bylaws, under the control, supervision and direction of its Board of Directors. The Board of Directors shall be elected by vote of a majority of a quorum of the Board of Volunteers of America of Western Washington. The number of directors constituting the Board of Directors shall be not less than 5 nor more than 15. Not less than two members of the Board shall also be members of the Board of VOAWW Inc., one of whom shall be the President/CEO of VOAWW, Inc. Not more than 6 members of the Board of Directors shall be independent of VOAWW, Inc. and shall meet the qualifications set forth in the bylaws of the corp. Directors may be removed by a vote of 2/3rd of the Board of Volunteers of America of Western Washington for any or no reason.

VIII. No real property of any type may be purchased, sold, encumbered, mortgaged or pledged by the Corporation without approval of the Board of Directors.

IX. The property of this Corporation is irrevocably dedicated to the purposes set forth in Section II of these Articles and to those purposes permissible under Section 501(c)(3) of the Internal Revenue Code and no part of the net income or assets of this organization shall ever inure to the benefit of any individual director, officer or member of the Corporation, except that reasonable compensation may be paid for services rendered to or for the Corporation.

X. The Corporation shall allow representatives of Volunteers of America, Inc., a New York Corporation to inspect all of its books, records, as well as other business documents, upon reasonable notice, to determine if the Corporation can continue being placed on the 501(c)(3) general exemption of Volunteers of America, Inc .

XI. The Corporation may be dissolved in accordance with the laws of the State of Washington. Dissolution may be approved by a vote of a majority of the Board of Directors. Should the Corporation be dissolved and/or liquidated, any and all assets, including real or personal property which remain after the payment of, or provision for the payment of, all debts and liability of this Corporation shall be distributed as follows:

(a) First to Volunteers of America of Western Washington, if such entity is still in existence and still organized and operated exclusively for one or more purposes set forth in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code and exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code.

(b) If Volunteers of America of Western Washington is no longer in existence or no longer organized as set forth above, regardless of the cause of revocation or renunciation, the property of this Corporation shall be distributed to Volunteers of America, Inc., a New York Corporation, if it is still exempt under Section 501(c)(3) of the Internal Revenue Code.


(c) If, for some reason, Volunteers of America Inc., is no longer in existence or exempt, then the property shall be distributed to another organization operated exclusively for charitable purposes under Section 501(c)(3) of the Internal Revenue Code.


(d) Consistent with the laws of the State of Washington, it is set out herein that if dissolution or liquidation becomes a necessity, that the Chief Executive Officer of Volunteers of America of Western Washington, or his or her designee, if the assets are to be distributed to such entity in accordance with subsection (a) above, or the Chief Executive Officer of the Volunteers of America, Inc., a New York Corporation, or his or her designee, if the assets are to be distributed to such entity in accordance with subsection (b) above, shall be appointed and commissioned, as provided by law, as the liquidator and/or administrator of the dissolution proceedings.

XII. These Articles may be amended by two-thirds (2/3rd) vote of the Board of Directors, but only if the proposed amendment or change is submitted in writing to the CEO of Volunteers of America, Inc. at least twenty-five (25) days prior to the date of the meeting wherein a vote on adoption of the proposal shall be had, and written notice of the proposed change submitted to the Corporation's Directors at least 10 days prior to the date of any proposed meeting. Before any amendment to these Articles can be made, approval of the CEO of Volunteers of America, Inc. must be obtained in writing.


