1. One new loan was processed during this fiscal year for a total of \$542,123.

2. Accrued interest for existing long-term loans increased revenue by \$145,086.

3. Program services expense for this activity were \$96,137.

4. Interest on trust funds was \$24,086.

1. Six homebuyer assistance loans were generated during this fiscal year for a total of \$423,119. Meriwest Credit Union purchased these loans for \$423,119.

2. Loan origination fees generated \$1,600 in revenue.

3. Program services expense to develop and manage the program were \$66,422.
