THE CORPORATION WILL OPERATE UNDER THE PROVISIONS OF SECTION 207/223(F) OF THE NATIONAL AFFORDABLE HOUSING ACT AND BE REGULATED BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) WITH RESPECT TO RENTAL CHARGES AND OPERATING METHODS. THE PROJECT'S MAJOR PROGRAM IS ITS SECTION 8 HOUSING ASSISTANCE PAYMENTS AND SECTION 207/223(F) DIRECT LOAN. THE PROJECT HAS EXECUTED A MORTGAGE AGREEMENT WITH U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD), WHICH REQUIRES THE UTILIZATION OF THE PROJECT PURSUANT TO SECTION 207/223(F) FOR A MINIMUM OF 40 YEARS.
