Nevertheless, because of the IRS' specific requirements, contributions of donated services and facilities have not been reported as contribution revenue on Form 990, Part VIII, Line 1f. Correspondingly, the associated program expenses have not been reported in Form 990, Part IX, Column B. (You will find the reconciliation of the audited financial statements to Form 990 on Schedule D, Parts XI and XII, where these differences are enumerated.) If the amounts were included on Form 990, Program Service expenses (Form 990, Part IX, Column B) would increase by \$1,873,473. In addition, revenues (Part VIII, Line 1f) would increase by the \$1,873,473.
