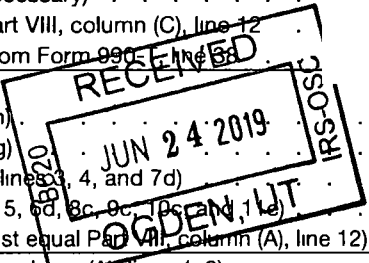

Compensation is determined annually by the Board of Directors based on current economic conditions and prevailing salaries among other economic development corporations. Currently there are no salaried individuals working for the corporation.
