THE PROJECT IS SPONSORED BY MOUNT ZION FIRST BAPTIST CHURCH AND PROVIDES SUBSIDIZED HOUSING TO THE ELDERLY. THE CORPORATION WILL OPERATE UNDER THE PROVISIONS OF SECTION 8 AND 207/223(F) OF THE NATIONAL AFFORDABLE HOUSING ACT AND BE REGULATED BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) WITH RESPECT TO RENTAL CHARGES AND OPERATING METHODS. THE REGULATORY AGREEMENT DOES NOT PERMIT ANY DISTRIBUTIONS TO THE CORPORATION SINCE IT IS A NON-PROFIT ENTITY.
