The Board of Directors uses this data to set the Chief Executive Officer's salaries. All other employee salaries were at and/or brought to 90% or higher of market value. Some employees were below and board approved to give the compensation to those employees immediately. Salaries for fiscal year 2018-19 were based upon the results of the 2017 study, with a 3% cost of living raise and 1.5% bonus.</p>
