FROM JULY 2019 UNTIL MARCH 2020, THESE CLASSES WERE OFFERED IN PERSON AND CONSISTED OF 74 CLASSES WITH A TOTAL OF 71 INDIVIDUALS PARTICIPATING IN THE 8 SESSION CURRICULUM; BEGINNING IN APRIL 2020, THE CLASS STARTED BEING OFFERED ON ZOOM ON A ONE ON ONE BASIS WHICH CONSISTED OF 43 INDIVIDUAL SESSIONS. COMBINING THE TWO, OPTIONS PROVIDED 609 LEARNING HOURS DURING THE TWELVE MONTHS ENDED JUNE 30, 2020. LASTLY, THE ORGANIZATION CONDUCTS CHILD SAFETY CLASSES IN CONJUNCTION WITH THE TEXAS DEPARTMENT OF STATE HEALTH SERVICES' SAFE RIDERS PROGRAM. 29 CLASSES WERE CONDUCTED AND 58 CAR SEATS WERE PROVIDED AND INSTALLED BY A CERTIFIED CAR SEAT TECHNICIAN. IN ADDITION, 50 CAR-SEAT CHECKS WERE PROVIDED FOR MEMBERS OF THE COMMUNITY WHO ALREADY OWNED CARSEATS BUT WANTED TO HAVE THEM CHECKED FOR PROPER INSTALLATION. THE PROGRAM WAS PUT ON HIATUS AS OF APRIL 2020 DUE TO COVID-19.</p>
