Two hot meals (breakfast and lunch) are served per day to up to 400 persons with a total of 121,000 hot meals served in 2016. An average of 85 households per day receives groceries from the Food Pantry for a total of 1,059,724 pounds of food distributed. Often, the meals and groceries provided at the Hospitality Center are the first steps to connecting with more comprehensive services such as homelessness prevention and Day Shelter services. The Center not only serves food to persons who are homeless but to those experiencing a housing crisis.

We work hand-in-hand with the St. Vrain Valley School District to ensure that Aspen Center graduates are more than ready to enter kindergarten.
