REMAINING PROGRAMS: THE PROFESSIONAL DEVELOPMENT COACHING PROGRAM CONNECTS WOMEN WITH A ONE- ON-ONE COACHING OPPORTUNITY TO HELP THEM SET PERSONAL, CAREER AND/OR BUSINESS GOALS. FOUR WOMEN WERE SERVED IN 2019. THE LOW-BONO LEGAL PROGRAM PROVIDES FAMILY LAW ASSISTANCE, FOR A NOMINAL FEE, TO THOSE WHO ARE FROM A LOW TO MEDIUM INCOME NEEDING ASSISTANCE WITH PRIMARILY DIVORCE, CUSTODY OR LEGAL SEPARATION ISSUES. IN 2019, 22 INDIVIDUALS WERE SERVED THROUGH THIS PROGRAM. WE CONTINUE TO PARTNER WITH THE SMALL BUSINESS DEVELOPMENT CENTER AT FORT LEWIS COLLEGE TO PROVIDE FREE, ONE-HOUR CONSULTATIONS WITH A BUSINESS EXPERT FOR WOMEN LOOKING TO LAUNCH A SMALL BUSINESS OR GROW AN EXISTING VENTURE. THE WOMENADE PROGRAM HELPS NORMALLY SELF-SUFFICIENT INDIVIDUALS OVERCOME UNEXPECTED FINANCIAL HARDSHIP WITH A ONE-TIME GRANT OF UP TO 500. IN 2019, 47 CLIENTS WERE ASSISTED THROUGH THIS ONE-TIME GRANT ASSISTANCE.
