Accomplishments: Parent Aids home visitation program utilizes the evidence-based SafeCare model and Parent Aid continues to be Arizonas only SafeCare accredited agency. The community-based parent education program implements the Active Parenting curriculum and has added Active Parenting of Teens to the menu services. This addition means Parent Aid now supports families with children birth through 18 years old. In the fiscal year ending August 31, 2020, Parent Aid provided in-home support to 56 families, including 92 parents and 121 children. Families strengthened their relationship with their children, learned how to identify home-safety hazards and enhanced their home-health skills. With the support of their Family Support Specialists, caregivers removed or secured 686 safety hazards in their homes, and improved bonding skills over 108%. Parent Aid provided 41 in-person parent education workshops in the fiscal year pre-COVID, and another 40 virtually post-COVID using the Active Parenting 4th Edition, Active Parenting: First Five Years, Active Parenting of Teens and Parent Aid produced curricula. Families built skills and knowledge in areas of: Child development Interpersonal communication Parental self-care Emotional regulation and expression Life skills (healthy nutrition, budgeting and safety) Handling problem behaviors Establishing family rules and expectations Community resources and supports Starting in March of 2020, to help with the extra parental stress of social distance mandates and shelter-in-place orders, Parent Aid began hosting virtual parent support groups. Since March 23rd, Parent Aid hosted 109 free groups open to all parents. The primary goal of all programming is the reduction of child maltreatment, with a secondary goal of strengthening families by building their parental knowledge, confidence, and support systems.</p>
