The Corporation's for-profit Associates have adopted financial accounting standards board, accounting standards codification (ASC) 740, income taxes, which requires an asset and liability approach for financial accounting and reporting for income taxes. The Corporation had no deferred tax assets or liabilities at June 30, 2019 or 2018.

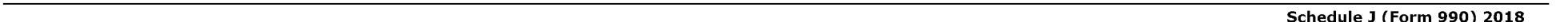

(REFERENCE FORM 990, PART IV, LINE 34) CUNNINGHAM MANOR GP, LLC IS RELATED, BECAUSE THE ORGANIZATION IS THE SOLE MEMBER. CUNNINGHAM MANOR GP, LLC ELECTED TO NOT BE TREATED AS A DISREGARDED ENTITY FOR INCOME TAX PURPOSES AND TO BE CLASSIFIED AS AN ASSOCIATION TAXABLE AS A CORPORATION.
