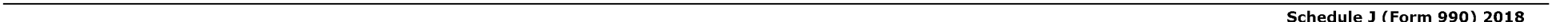

HCS OWNS 100% OF THE VOTING COMMON STOCK OF WMI. THE EXECUTIVE DIRECTOR OF HCS, WHO IS ALSO THE EXECUTIVE DIRECTOR OF THE ORGANIZATION, SERVES AS AN OFFICER AND A DIRECTOR OF WMI. TOGETHER HCS, WMI, AND Three OTHER HCS AFFILIATES PAY THE COMPENSATION AND BENEFITS FOR THE EXECUTIVE DIRECTOR. WMI PROVIDES PROPERTY MANAGEMENT AND ACCOUNTING SERVICES TO THE ORGANIZATION.
