to retention of the position and any salary adjustments to the full Board for
approval.

Pt VI, Line 15b: Human Resources researches salary comparability data for similar
positions, and organizations of similar size and industry. The Executive Director
reviews the salary information and applicant experience to determine appropriate
compensation.
