These include active and retired physicians, dentists, nurses, and other medical personnel, as well as administrative volunteers. The clinic is funded by private donations from individuals, corporations, foundations, and civic groups. The clinic does not receive any state or federal funding. In 2019, MVC succeeded in serving 778 patients and providing 6,615 patient encounters. MVC provided \$1,067,998 in prescription medication assistance to our patients. Services include, but are not limited to, primary medical care, dental exams, x-rays, cleanings, fillings and extractions; eye exams and prescription eye glasses; dermatological care; gynecological care; breast health services (screening mammograms, diagnostic mammograms, ultrasounds, biopsies, etc.); laboratory services; diagnostic services; radiology services; cancer screenings; nutrition counseling; mental health counseling; specialty consults; and outpatient surgery.
