Social Detox - The Social Detox Program provides a safe and comfortable setting for an alcoholic woman to physically separate from alcohol while being immersed in support and education from recovered women so that she may learn about alcoholism and begin practicing 12-Step spiritual principles to achieve sobriety. In 2018, we admitted 325 women to our Social Detox Program, 74% of whom successfully completed the program. Volunteer Program Coordinators (overnight volunteers) donated 6,152 hours to our Social Detox Program, with 82% of those volunteer hours coming from Social Detox alumnae.

Peer Recovery - The Peer Recovery Program is a recovery enrichment program that provides any alcoholic woman the opportunity to find and sustain lifelong recovery by growing in understanding and effectiveness of 12-Step spiritual principles through intensive work with other alcoholics so that she may experience an improved quality of life. In 2018, we had 8,242 visits to our Peer Recovery Program meetings, classes and workshops facilitated by volunteers who donated 1,216 hours to this program.

Community Outreach - The Community Outreach Program is dedicated to engaging all resources to enhance our efficacy in the treatment of alcoholism and any other unique sets of circumstances that our clients may have. When organizations unify and educate one another, it permits us all to address more women and their families and build a stronger community. In 2018, we were able to hire a full-time staff member to focus solely on nurturing our current partnerships as well as cultivate new ones. Our Community Outreach Program consists of over 100 collaborative partnerships with local non-profits.
