In 2016 the Organization began a capital campaign with the intention of increasing service capacity by an additional 30 guest rooms to meet the increased request for rooms at the supported organization, Ronald McDonald House of Dallas (RMHD). In 2017, RMHD turned away 983 families due to lack of space. Following a comprehensive feasibility study, the Trustees and RMHD Board of Directors approved the expansion from 58 to 88 guest rooms. This expansion will add 18,000 square feet. Included will be six larger suites for longer stay families. The capital campaign will also allow for updates to the existing building including refurbishment of floors, adding chest of drawers to family guest rooms, upgrading technology, and adding artwork to family hallways. RMHD expects to break ground on the expansion before the end of 2018.

used for children who have received bone marrow, stem cell, or organ transplants who, post transplant, must remain close to the hospital and in an isolated environment. In addition to the bedrooms and suites, the House has many common areas including a library, arts and crafts room, play room, game room, community room, teen room, media room, chapel and meditation garden and large outdoor play areas. Additionally, the House has a Day Program available to children receiving inpatient or outpatient care and their families who do not need the overnight accommodations of the House because they live within easy driving distance of the hospital, but still need a place for rest and relaxation. Additionally the FAF maintains an assistance fund for the benefit of the residents of the Ronald McDonald House. Family Assistance to residents of the RMHD who qualify includes scholarships for former patients, their siblings and parents, cab fare to and from the hospital or airport, and when necessary, assistance with funeral expenses. In 2017 the Family Assistance Foundation provided scholarships totaling \$13,854 to thirteen former patients and family members. Additionally, the FAF provides recreational outings and hotel expenses when the RMHD cannot accommodate families.
