IF THE CONFLICT PERTAINS TO A MATTER THAT IS NOT BEFORE THE BOARD OR COMMITTEE, THEN THE DIRECTOR DISCLOSES THE CONFLICT TO THE BOARD PRESIDENT AND EXECUTIVE DIRECTOR AS SOON AS THE DIRECTOR BECOMES AWARE OF THE ACTUAL OR POTENTIAL CONFLICT. FAILURE TO DISCLOSE AN ACTUAL OR POTENTIAL CONFLICT OF INTEREST MAY BE GROUNDS FOR DISCIPLINARY ACTION BY THE BOARD, INCLUDING REMOVAL FROM THE BOARD. ON AN ANNUAL BASIS, THE DIRECTORS ARE REMINDED OF THIS POLICY.
