Arlington Urban Ministries serves Arlington residents without regard to any differences, such as, race, sex, ethnicity, age, religion, and non-religion. Arlington Urban Ministries serves clients who are homeless, exited from homeless and battered women's shelters, sick, elderly, unemployed and the working poor. In 2016 Arlington Urban Ministries served 1,665 clients.
