Arlington Urban Ministries serves Arlington residents without regard to any differences, such as, race, sex, ethnicity, age, religion, and non-religion. Arlington Urban Ministries serves clients who are homeless, exited from homeless and battered women's shelters, sick, elderly, unemployed and the working poor. In 2018 Arlington Urban Ministries served 1,168 clients.

NU2U is a retail thrift shop that sells gently used clothing at greatly reduced prices.
