In-house, they perform the duties of caring for their home including cooking, cleaning, general maintenance of the house, property, and vehicles, assist with homeless services, and monitor security. SHM provides their meals (32,850/year), clothing and shelter (10,950 nights/year) during their program and as the re-integrate into the community.

Bend Emergency shelter is open year round in a permanent location. We provide breakfast, lunch and dinner every day for men, women, and children, serving up to 23,000 meals a year, offering 5,000 nights of stay for men, 1,500 showers for men and women, and 10,000 pieces of clothing, hygiene items, sleeping bags, backpacks, and tents, when available. In addition, guests are welcome to attend classes and participate in community which often leads to entry into the long-term Discipleship & Habilitation program. We also offer assistance and information to help guests locate permanent housing and access to services and reconnect with family. Medical assistance is provided weekly at our location by Mosaic Medical. During 2020 during the COVID-19 Pandemic, Shepherds House stepped up to meet the new and growing food needs of our community. On March 23, 2020, our residents began distributing food boxes, clothing and toiletries at a drive-by station Monday thru Friday. As of June 30, we have provided more than 2,122 boxes containing 11,851 meals. This in addition to the normal food service that we provide for the homeless population and our residents. We will continue to provide this service as the COVID-19 Pandemic and needs continue.

Our women have the opportunity to work on completing their GEDs, go to college, or train for jobs as they move through the phases. In-house, they perform the duties of caring for their home including, cooking, cleaning, general maintenance of the house, and gardent. SHM provides their meals (8,760/year), clothing and shelter (2,920 nights/year) during their program and as the re-integrate into the community. Additionally, during weekends, we accomodate up to 18 children who spend time with their moms at the Womens Center.
