Families Forward's mission is Fostering Personal Achievement for Central Oregonians. The purpose of the organization is to develop, own and operate low income housing and provide services to residents of Housing Works properties as well as participants on the Housing Choice Voucher program. These core services include Family Sustainability, Personal Asset Building, and Opportunities for Kids.

Program Description: Families Forward provides affordable housing opportunities to low income households throughout Central Oregon through 3 primary channels: 1) Families Forward owns and operates 16 units of low-income housing for senior and/or disabled households in the city of Redmond, state of Oregon; 2) Families Forward also administers a HUD continuum of care grant providing rental subsidy for two individuals with chronic medical conditions who were formerly homeless; 3) Families Forward develops single family homes and sells the improvements with a ground lease to homebuyers at or below 80% of area median income. Program Objective: Provide a spectrum of affordable housing options to those in need. Long Term Goal: strong stewardship of existing fixed assets and the creation of new affordable housing opportunities an resources. Number of people served: 21 low income households.

4b (Code:) (Expenses \$ 3,307 including grants of \$) (Revenue \$ 2,508)

Program Description: Families Forward has created a revolving loan fund to be used to pay for rental security deposits. Program Objective: Assist low income households by funding security deposits to offset the costs involved with obtaining rental housing. Long Term Goal: To attract additional donors and increase program funding. The goal is to continue providing access to the funds necessary for low income households to obtain rental housing and prevent them from becoming or remaining homeless. Number of people served - 23 new loans made during fiscal year at an average of \$432 per household (a total of 48 currently active loans).

Program Description: Provides an array of services to Housing Works properties, including Boys and Girls Clubs and other after school programs, youth camps, homeownership and tenant readiness counseling and career enhancement skills. Long Term Goal: Enhance existing on-site programs and offer additional programs to residents of Housing Works properties.
