In 15 of Nevada's 17 counties, this department provides childcare resource and referral to assist parents in their search for childcare and administers childcare subsidies to parents who are low income and working, in job training, or actively seeking employment. Quality enhancement services are provided statewide. These programs include parent and early learning provider training, community outreach and education, early childhood system building and support, quality rating and improvement system onsite coaching for licensed childcare, and early childhood support network, which provides substitute childcare providers to licensed childcare facilities.

## **Form 990, Part III, Line 4b:**

Family and Youth Interventions - this department includes family counseling, case management, runaway and homeless youth outreach, safe place, onsite high school, and workforce development programs. Family counseling is provided at no charge to families with children/youth between ages of birth and twenty-four. Case management is a component of many programs and may include home visits, school visits and onsite services. Runaway and homeless youth outreach is conducted throughout the community providing resources, including information on our safe place program. Safe place is a 24/7 phone/text number that youth who find themselves in an unsafe situation can contact for immediate access to a Children's Cabinet case manager. The Cabinet's onsite high school is Redfield Academy, a high school for youth that are severely credit deficient, they receive intensive case management and academic support to meet their educational goals. Youthbuild is a workforce development program that reengages youth with education and provides construction education and certifications. An onsite food pantry provides families with access to food, hygiene, and other basic necessities. Additional programs in FYI allow for the full spectrum of wraparound services (clothing closet, and emergency assistance).
