In addition, the board treasurer conducts periodic surveys of compensation levels for similar not for profit organizations. Each year performance goals are set for the executive director by the executive committee. At year-end, the executive committee reviews actual performance versus goals. Based on results, the executive committee determines the percentage of goals achieved which determines the bonus amount of the executive director.
