We offer an education program that provides tools and resources for families to lift themselves out of poverty, and a social safety-net of community and support. That support includes providing basic necessities and food to families participating in our education programs. We served 273 unique families representing 1,053 individuals. We provided 160 live online classes with 4,238 log-ins on life-changing topics such as financial literacy, digital skills, ESL, health & wellness, and fostering financial independence. We hosted 24 drive-thru distributions of basic necessities and food donation boxes, and distributed 17,073 items of basic necessities and 127,460 pounds of food.
