Valley View Community Food Assistance provided more than 650,000 clients with food boxes at a cost of \$ 35 per box. There were 162,000 food distributed A family receives more than \$300 worth of food in their food box, which is enough food for three to five days The food bank received 4,481,978 pounds of food from individual donors as well as various agencies at a cost of \$2 25 per lb for a total dollar amount of \$7,645,068 00 In addition to cash donations/contributions being used to cover employee wages for employees needed in order to handle these food donations, building leases, utilities, vehicle expenses, etc , donations are also used used to purchase staples, canned goods, meat and produce. Along with the distribution of food boxes for individuals and families, the food bank also helps some families with emergency living expenses, i.e , rent, utilities, care repairs etc.

Valley View Community Food Assistance also has a senior program which whereby seniors have a designated day to pick up food boxes Of the more than 650,000 clients 297,700 are seniors. In addition to the senior program Valley View also provided food to 18 small agencies, such as foster group homes, homeless shelters, youth groups, women's shelters, and small food pantries

During Easter of 2020 over 6,000 individuals received an extra food box, and 2,500 childred received Easter baskets

At least 2,000 children received Christmas gifts. There were 300 gift bags distributed to homeless individuals and over 300 grandparents raising grandchildren received a special treat just for them
