THE CORPORATION WILL OPERATE UNDER THE PROVISIONS OF SECTION 202 OF THE NATIONAL AFFORDABLE HOUSING ACT AND BE REGULATED BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) WITH RESPECT TO RENTAL CHARGES AND OPERATING METHODS. THE PROJECT'S MAJOR PROGRAM IS ITS SECTION 202 CAPITAL ADVANCE AND PROJECT RENTAL ASSISTANCE. THE PROJECT HAS EXECUTED A CAPITAL ADVANCE AGREEMENT WITH U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD), WHICH REQUIRES THE UTILIZATION OF THE PROJECT PURSUANT TO SECTION 202 FOR A MINIMUM OF 40 YEARS.
