THE MISSION OF ONE HEART SOURCE IS TO EMPOWER PEOPLE, PARTICULARLY VULNERABLE CHILDREN, THROUGH HIGH QUALITY EDUCATION AND CARE ONE HEART SOURCE USES INTERNATIONAL COLLABORATION AND DEVELOPMENT TO ELIMINATE THE GAP BETWEEN THOSE WHO HAVE ACCESS TO BETTERING THEIR OWN LIVES AND THOSE WHO DO NOT CURRENT PROGRAMS INCLUDE YOUTH EMPOWERMENT MENTORSHIP PROGRAMS IN SOUTH AFRICA AND JAMAICA, AS WELL AS THE ONE HEART SOURCE CHILDREN'S WELFARE NETWORK IN TANZANIA

ONE HEART SOURCE (OHS) OPERATES SOCIAL UPLIFT PROGRAMS DESIGNED TO EMPOWER INDIVIDUALS, PARTICULARLY VULNERABLE CHILDREN, LIVING WITHIN MARGINALIZED POPULATIONS GLOBALLY OHS PROGRAMS PROMOTE A COMPREHENSIVE APPROACH, THROUGH INTERNATIONAL COLLABORATION AND DEVELOPMENT, TO ELIMINATING THE GAP BETWEEN THOSE WHO HAVE ACCESS TO BETTERING THEIR LIVES AND THOSE WHO DO NOT THE MANTRA OF ONE HEART SOURCE IS 'UPLIFT WITH HUMANITY', AND, IN 2015, OHS OPERATED FOUR MAIN BRANCHES OF UPLIFT PROGRAMS CHILDREN'S WELFARE IN TANZANIA, EDUCATION IN SOUTH AFRICA, EDUCATION IN JAMAICA, AND THE GLOBAL OHS COLLECTIVE IN 2015, PROGRAMS IN TANZANIA WERE FOCUSED ON PROVIDING HIGH QUALITY EDUCATION AND CARE TO VULNERABLE CHILDREN VIA THE OHS CHILDREN'S WELFARE NETWORK IN ARUSHA, TANZANIA THE PURPOSE OF THE OHS CHILDREN'S WELFARE NETWORK IS TO SUPPORT THE WELL-BEING, GROWTH, AND DEVELOPMENT OF VULNERABLE, ABANDONED, AND ORPHANED CHILDREN IN ARUSHA, TANZANIA ORIGINALLY ESTABLISHED IN 2008 AS THE THE OHS CHILDREN'S WELFARE CENTER, THE CENTER LATER EVOLVED INTO A MOBILE SOCIAL WELFARE NETWORK THAT DESIGNS AND IMPLEMENTS SUSTAINABLE LIFE PATHS FOR EACH ENROLLED CHILD BASED ON THEIR AVAILABLE WEB OF CARE AND ACADEMIC OPPORTUNITIES OHS WORKS WITH TANZANIAN SOCIAL WORKERS AND THE CHILD'S SURVIVING FAMILY MEMBERS TO CAREFULLY RESEARCH THE FAMILY HISTORY AND AVAILABLE NETWORK OF CARE FOR EVERY CHILD ENROLLED IN ONE HEART SOURCE RE-INTEGRATION INTO THE CHILD'S BIOLOGICAL FAMILY IS CONSIDERED TO BE IN THE BEST INTEREST OF THE CHILD WHENEVER POSSIBLE, THROUGH CAPACITY BUILDING AND CAREFUL TRIALS AND MONITORING, AS IT CREATES A LONG-TERM, NON-INSTITUTIONAL SOLUTION FOR THE CHILD IN THIS CAPACITY, THE OHS WELFARE NETWORK SERVES AS THE BRIDGE TO A LONG-TERM POSITIVE SOLUTION FOR EACH CHILD, PROVIDING COMPREHENSIVE RESOURCES TO SUPPORT THE OVERALL WELL-BEING OF THE CHILD CHILDREN'S INDIVIDUAL LIFE PATHS ARE CAREFULLY MONITORED BY OHS SOCIAL WORKERS AND CAREGIVERS IN ORDER TO ENSURE THAT THEY RECEIVE THE SUPPORT THEY NEED TO GROW, LEARN, AND BECOME CONTRIBUTING MEMBERS OF THEIR COMMUNITIES THIS SUPPORT INCLUDES BUT IS NOT LIMITED TO EDUCATION - FULL SCHOLARSHIP TO ATTEND TOP LOCAL PRIVATE SCHOOLS, SCHOOL SUPPLIES, EXTRACURRICULAR ACTIVITIES, AND OTHER SCHOOL-RELATED NECESSITIES, HEALTH - ACCESS TO HIGH QUALITY MEDICAL AND DENTAL CARE, NUTRITION - HEALTHY, NUTRITIOUS FOOD AND CLEAN WATER, JOY - ENTERTAINMENT, EXCURSIONS, AND PLAY, AND GENERALLY MAXIMIZING LIFE OPPORTUNITY OVERALL, THE GOAL OF ONE HEART SOURCE IS TO OFFER EACH CHILD IT SERVES THE HIGHEST QUALITY OF LIFE POSSIBLE BY IMPROVING THE QUALITY OF DAILY NUTRITIONAL VALUE, ACADEMIC AND SOCIAL LEARNING, PERSONAL CARE AND ATTENTION, OPPORTUNITY, CHOICE, AND FREEDOM ONE HEART SOURCE IS CONSTANTLY REFINING ITS ORGANIZATIONAL MODEL AND METHODOLOGY IN ORDER TO MEET THE ANTICIPATED NEEDS OF THE CHILDREN UNDER ITS CARE TO ENSURE THAT THEY HAVE THE BRIGHTEST, MOST VIBRANT FUTURES POSSIBLE PROGRAMS IN SOUTH ETHNICITIES, AND FAITHS TO MENTOR STUDENTS AT THE LOCAL PRIMARY SCHOOL OHS ESTABLISHED THE INAUGURAL GIFTED COMMUNITY IN 2012, AND IT HAS GROWN STEADILY SINCE THEN EACH YEAR, A NEW COHORT OF STUDENTS IS ENROLLED IN THE PROGRAM THESE STUDENTS ARE SELECTED IN COLLABORATION WITH TEACHERS AND OFTEN RANK IN THE MIDDLE-BOTTOM RANGE OF THEIR CLASS IN READING AND MATHEMATICS, THOUGH EXCEPTIONS ARE MADE GIFTED STUDENTS ENGAGE IN MENTORSHIP THROUGHOUT THE WEEK WITH OHS MENTORS IN A LOW STUDENT-TO-MENTOR RATIO THIS ALLOWS US TO TAILOR INSTRUCTION TO THE SPECIFIC NEEDS OF EACH STUDENT, CREATING A CONDITION IN WHICH RAPID ACADEMIC GROWTH IS POSSIBLE STUDENT PROGRESS IS CAREFULLY TRACKED WITH PERIODIC ASSESSMENTS AND COMMUNICATION IS MAINTAINED BETWEEN OHS LEADERS AND THE CHILDREN'S TEACHERS AND PARENT/GUARDIAN(S) OHS IS CONSTANTLY DEVELOPING AN ECOSYSTEM FOR COLLABORATIVE EXCHANGE IN ORDER TO HOLISTICALLY PROVIDE THE BEST LEARNING ENVIRONMENT POSSIBLE FOR OUR STUDENTS, WHICH IN 2015 INCLUDED WORKING IN PARTNERSHIP WITH SCHOOL ADMINISTRATION AND FACULTY, LOCAL NGOS, AND COMMUNITY LEADERS WE STRIVE TO WORK TOGETHER WITH EVERY STAKEHOLDER IN OUR STUDENTS' LIVES THE MAIN GOALS OF THE GIFTED COMMUNITY ARE TO PROVIDE HIGH-QUALITY MENTORSHIP IN AN ENVIRONMENT WHERE ALL STUDENTS HAVE AN OPPORTUNITY TO THRIVE ACADEMICALLY, PERSONALLY, AND CREATIVELY DESPITE SIGNIFICANT SOCIOECONOMIC DISADVANTAGES, TO CREATE A CULTURE OF RESPECT FOR ONESELF, OTHERS, AND ONE'S COMMUNITY, TO DEVELOP A WEB OF SUPPORT FOR STUDENTS THAT INCLUDES TEACHERS, FAMILIES, AND MENTORS, AND TO DESIGN OPPORTUNITIES FOR STUDENTS AND VOLUNTEERS TO EMPOWER EACH OTHER THROUGH HUMAN CONNECTION THE CORE ACADEMIC GOAL OF THE GIFTED COMMUNITY IS TO GENERATE MEASURABLE IMPROVEMENT IN READING AND MATHEMATICS FOR ALL ENROLLED STUDENTS IN ORDER TO PROVIDE THE MOST HOLISTIC MENTORSHIP POSSIBLE FOR OUR STUDENTS WE ALSO EMPHASIZE THE ARTS, CRITICAL THOUGHT, AND THE BUILDING OF CHARACTER AFTER-SCHOOL, WEEKEND, AND HOLIDAY PROGRAMS OFTEN INCORPORATE A VARIETY OF ARTS, SPORTS AND EXTRACURRICULAR ACTIVITIES TO ENCOURAGE STUDENTS TO ENGAGE CREATIVELY AND TO PROVIDE A SAFE, CONSTRUCTIVE USE OF TIME STUDENTS ALSO JOIN THEIR OHS MENTORS ON FIELD TRIPS AND OTHER OUTINGS WITHIN THE GREATER CAPE TOWN AREA IN ORDER TO ENGAGE WITH LOCAL SURROUNDINGS AND ENCOURAGE EDUCATION BEYOND THE PHYSICAL CLASSROOM AFTER A PILOT PROGRAM IN 2014, A WORKING PROTOTYPE OF A NEW HEALTH FOCUS PROGRAM FOR THE GIFTED COMMUNITY WAS LAUNCHED IN 2015 THE GOALS OF THE HEALTH PROGRAM ARE TO FOCUS ON HEALTH-CAREER MENTORSHIP FOR GIFTED SCHOLARS BY CONNECTING INTERNATIONAL, PRE-HEALTH PROFESSIONALS TO THEIR ASPIRING COUNTERPARTS IN PRIMARY SCHOOL, AND TO ENGAGE WITH LOCAL AND GLOBAL COMMUNITY HEALTH REALITIES WHILE EXAMINING POTENTIAL SOLUTIONS THROUGH AN EDUCATION-BASED LENS FOCUSED ON INNOVATION AND ENTREPRENEURSHIP A COHORT OF GRADE 6 STUDENTS FROM THE GIFTED COMMUNITY WHO EXPRESSED A DESIRE TO BECOME FUTURE HEALTH PROFESSIONALS WERE SELECTED AND ENROLLED IN THE INAUGURAL PROGRAM THEY WERE THEN PAIRED WITH MENTORS FROM ACROSS THE WORLD WHO ARE EITHER UNIVERSITY STUDENTS OR GRADUATES IN A HEALTH-RELATED FIELD MENTORS ALSO HAD THE OPPORTUNITY TO NETWORK WITH LOCAL HEALTH ENTREPRENEURS AND ORGANIZATIONS THROUGHOUT THE CAPE TOWN AREA IN ORDER TO CONTEXTUALIZE AND BETTER UNDERSTAND THE LOCAL HEALTH ECOSYSTEM THE HEALTH FOCUS PROGRAM IS THE FIRST IN A LINE OF PROPOSED EDUCATIONAL BRANCHES IN THE GIFTED COMMUNITY SUBJECTS IN CONSIDERATION FOR FUTURE PROGRAM DEVELOPMENT INCLUDE ENTREPRENEURSHIP, PERFORMING ARTS, & BUSINESS STUDIES IT IS OUR HOPE THAT THE GIFTED COMMUNITY WILL PROVIDE A STRONG AND LOVING COMMUNITY FOR THE STUDENTS TO DEPEND ON AND UTILIZE TO SUCCEED ACADEMICALLY AND PERSONALLY IN THEIR AND EMBRACE THEIR ROLE AS EMPOWERED GLOBAL CITIZENS 2015 ALSO MARKED THE INCEPTION OF A NEW GLOBAL LOCATION FOR OHS PROGRAMS IN MONTEGO BAY, JAMAICA PROGRAMS IN JAMAICA FOCUSED ON MENTORSHIP PROGRAMS DESIGNED TO PROVIDE INTENSIVE INSTRUCTION IN ENGLISH AND MATHEMATICS TO LOCAL STUDENTS A TEAM OF INTERNATIONAL VOLUNTEERS COLLABORATED WITH SCHOOL LEADERSHIP IN OUR PARTNER COMMUNITY TO CONDUCT AN ACADEMIC MENTORSHIP PROGRAM AT A LOCAL PRIMARY AND JUNIOR HIGH SCHOOL, PROVIDING STUDENTS WITH DAILY INSTRUCTION IN READING AND MATHEMATICS AT AN AVERAGE OF 3 1 STUDENT-TO-MENTOR RATIO, BASED ON ASSESSMENTS AND COLLABORATION WITH LOCAL TEACHERS STUDENTS AND MENTORS ALSO DISCUSSED VARIOUS ASPECTS OF JAMAICAN CULTURE AND HISTORY LESSONS WERE FRAMED IN ORDER TO MAKE GLOBAL CONNECTIONS, AND EACH WEEKLY TOPIC WAS EXPLORED THROUGH DIFFERENT MEDIUMS INCLUDING READING, ART, MUSIC, DANCE, AND THEATER THESE SESSIONS CREATED AN OPPORTUNITY FOR THE VOLUNTEER COLLECTIVE TO LEARN MORE ABOUT JAMAICA AND FOR STUDENTS TO TAKE A LEADERSHIP POSITION BY SHARING THEIR INSIGHT IN 2015, A GLOBAL TEAM OF NEARLY 150 VOLUNTEERS WAS RECRUITED FROM UNIVERSITIES ALL OVER THE WORLD, AND COHORTS OF VOLUNTEERS COORDINATED TO SERVE AS MENTORS IN OHS UPLIFT PROGRAMS IN JAMAICA AND SOUTH AFRICA OUR INTERNATIONAL MENTORSHIP PROGRAMS ARE MADE POSSIBLE ENTIRELY BY
