Chelan Valley Hope provides assistance, advocacy and referral services to under-resourced families and individuals throughout the Greater Chelan Valley. Chelan Valley Hope is a hub for compassionate community connections and resources. Our purpose is two-fold: helping individuals and families in crisis access basic needs like food, transportation, utilities, rent, clothing, emergency

Chelan Valley hope has provided confidential intake and assessment of more than 250 households and has provided emergency stipends to assist with rent, utilities, gas, car repairs, bus tickets, medical care, clothing, and more. Our organization helps clients develop a plan to achieve or restore solvency and we connect clients with resources for continued recovery, growth, and long-term success. In 2018, we assisted over 670 individuals. In the past, we have partnered with "Feed My Starving Children", "Art with Heart", "Back to School Fairs" and other community projects to raise funds that support various efforts and programs. In addition, in 2015, Chelan Valley Hope joined with other agencies in Chelan and Douglas Counties to form a Community Housing Network with the purpose of providing coordinated access to housing and shelter for residents facing homelessness. In 2016, CVH was approved for an 18-month grant through the City of Wenatchee used: 1) to comply with coordinated homeless data entry; 2) to provide case management services to at-risk client families; and 3) to pay for certain shelter and rehousing expenses with the ultimate goal of reducing the incidence of homelessness and housing insecurity in our local community. During 2018, 42 households received emergency shelter for an average of 3 nights and case management services to locate more stable housing.

4b (Code:) (Expenses \$ 23,619 including grants of \$) (Revenue \$ 16,915)

Chelan Valley Hope is committed to managing and safekeeping donor advised funds. We have the shared mission of helping people easily access essential resources, and together we can leverage our assets to multiply our reach. Funds include MANGER MALL, bringing a happy Christmas every year to over 300 needy families and over 1,100 kids, and TLC for Seniors Program which improves the care and support of vulnerable seniors (age 60+) in Chelan Valley through personal contact by a trained volunteer friend. The goal is to help meet the needs of seniors who wish to have an excellent quality of life in their own home. This is done by providing assistance with chosen activities and with access to outside services when needed. Each volunteer is paired with a senior after an in-home assessment by the TLC Coordinator. Then the volunteer and the senior together work out a schedule of visits and agreed upon tasks such as playing cards, doing a puzzle, making needed health appointments or arranging for transportation. The program has been in operation for two years and has a capacity of 30 seniors at present.

Keep Cornerstone Capital Campaign: The purpose of the capital campaign was to purchase the building located at 417 S. Bradley Street from the City of Chelan. The Cornerstone building is home to local non-profit relief organizations that coordinate efforts and leverage resources to maximize assistance to struggling, under-resourced area residents. The organizations are Chelan Valley Hope, The Food Bank, Catholic Family Services, Manger Mall, Celebrate Youth Recovery, and English Second Language Classes. Many donors and businesses in the community have helped Chelan Valley Hope to purchase the Cornerstone Building, giving the compassionate community organizations a permanent home. The first phase of Chelan Valley Hope's project, to purchase the Cornerstone building was complete in March 2016.
