Family Development - This service group provides various childcare services such as provider training and technical assistance; parent training; resource and referral; payment assistance; and nutritional training and meal payment assistance. Service estimates in units of children - 3,368 families received \$7,898,482 of childcare payment assistance. Additionally 957 providers received training, 72 providers received nutritional training, and 19 tribal care providers received training. CARES Act Special Circumstance In-Home Care Scholarships provided \$2,373,000 in assistance to 594 families.

Form 990, Part III, Line 4b:

Energy Programs - This service group provides weatherization, utility payment assistance and education to qualified participants. Utility assistance consists of: 1) Eligibility for Montanas Energy Share program - approximately \$433,063 in utilities were provided to 742 households. Additionally, 2) LIEAP heat utility payments, energy education and credit counseling, and crisis intervention for heating emergencies - approximately \$2,210,712 in utilities was paid for 2,738 households and portions of these households received other conservation services. Approximately 3,276 homes received energy education. Weatherization services increased heating efficiency and reduce utility bills for low income eligible participants through approximately \$716,202 in insulating; door, window and furnace repair and replacement. An estimated 103 eligible homes were assisted, or 214 people.

Form 990, Part III, Line 4c:

Emergency Food and Housing - This service group provides housing, food and other emergency services to eligible recipients. Transitional living services helped homeless pregnant and /or parenting youth ages 18-21 in a safe living environment. Housing services consist of counseling, emergency payments, and housing placement services to assist low income and homeless populations. Approximately, 347 individuals completed Homebuyer Education, 380 individuals received homebuyer pre-purchase counseling, and 3 individuals received rental counseling. Housing programs aided 140 households in receiving Section 8 housing valued at \$798,142. Approximately \$228,403 was provided to 112 households in the form of housing payments and supportive services to assist clients in maintaining or moving into permanent housing. Forty-eight households received deposit assistance totaling \$39,206. Harmony house served 24 pregnant and parenting youth. The participants received \$20,803 in direct supportive services, \$1,421 in security deposits, and \$15,191 in rent payments. Family Forwards served 70 participants which were able to obtain/maintain housing. Food assistance is provided through the distribution of food to eligible families living on the Crow Indian Reservation. Monthly, food commodities were distributed to approximately 516 individuals, or 241 Crow Tribe Families for a total annual value of \$144,265.

TANF and food stamp recipients an d eligible youth receive these services to assist them in entering and staying in the work place. Service estimates included 778 enrollments, 268 positive case resolutions and \$64, 533 in direct supportive services for welfare recipients. There were 29 case resolutions f rom 99 participants, and \$7,970 in direct supportive services for food stamp recipients. A pproximately \$54,700 in wages was provided to 66 youth engaging in employment training opp ortunities. In addition to work place assistance, and \$14,476 in direct supportive service s. Intensive case management targeted towards completion of education and involvement comm unity service activities. Fourteen students received over 810 hours of tutoring for Hi-SET /GED testing. OTHER PROGRAM SERVICES 5: Emergency Food and Housing - This service group pr ovides housing, food and other emergency services to eligible recipients. Transitional liv ing services helped homeless pregnant and /or parenting youth ages 18-21 in a safe living environment. Housing services consist of counseling, emergency payments, and housing place ment services to assist low income and homeless populations. Approximately, 347 individual s completed Homebuyer Education, 380 individuals received homebuyer pre-purchase counselin g, and 3 individuals received rental counseling. Housing programs aided 140 households in receiving Section 8 housing valued at \$798,142. Approximately \$228,403 was provided to 112 households in the form of housing payments and supportive services to assist clients in m aintaining or moving into permanent housing. Forty-eight households received deposit assis tance totaling \$39,206. Harmony house served 24 pregnant and parenting youth. The partici pants received \$20,803 in direct supportive services, \$1,421 in security deposits, and \$15, 191 in rent payments. Family Forwards served 70 participants which were able to obtain/mai ntain housing. Food assistance is provided through the distribution of food to eligible fa milies living on the Crow Indian Reservation.
