Part I, line 16: Other expenses includes one-half of building expenses for insurance (\$808), repairs and maintenance (\$1,563), Utilities (\$5,004) real estate taxes (\$647), and depreciation (\$2,445). The building is also used by a church that serves our target community and furthers our nonprofit purpose. In addition are included other taxes and fees incurred by the organization.

Part II, line 26, total liabilities includes real estate prepaid taxes from homebuyers (\$12), short-term operating loan (\$10,000), and long-term operating loan (\$30,000).
