

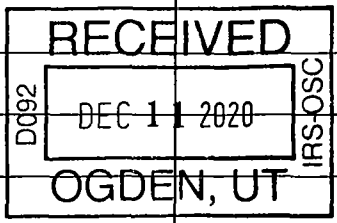

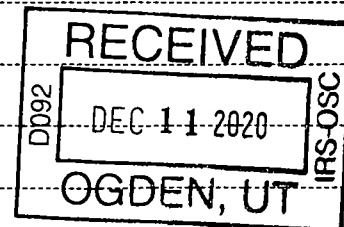

- Hosted monthly Each Other's Keeper Mentoring peer-support meetings and linked new clients with mentors
- Provided Case Management and follow up (Reentry, Risk Assessment, Direct Services, Ongoing Support and Advocacy)
- Hosted monthly R.I.S.E. (Reentry Initiative Supporting Entrepreneurship) workshops
- Hosted housing and homelessness Lunch & Learn for Community Supervision (Parole/Probation) Officers with City of Hinesville in March
- Hosted Mini Job Fair in June 2019, which included work orientation, application assistance and interviews.

- Monthly Outreach to Atlantic Judicial Circuit western including Evans, Tattnall and Long Counties

Speakers included School Superintendent Dr. Franklin Perry, Juvenile Judge Linnie Darden, and mentee organization leaders.
- Assisted clients with emergency shelter and housing support, provided 103 nights of shelter in collaboration with local providers.
