During the pandemic, the distribution of food and PPE has been the focus of the Health and Wellness initiatives. As such, in 2020 almost 30,000 families received 900,000 pounds of food. CHF has learned and grown through partnerships with vendors Go Fresh and DiMare, where CHF provided the last mile distribution. Expenses included approximately \$45 of food (in-kind, USDA provided) that supported a family of four for three days. Participants received a food box that included produce, protein, and dairy. An additional \$20 of direct expenses provided for Personal Protective Equipment, the trucks, forklifts and golfcarts needed to fulfill the event needs, the average cost per family served totaled \$65. A food distribution weekend involves considerable planning, partnerships, and logistics, including the participation of dozens of volunteers.

Healthy Dollars is a financial literacy program providing interactive education to achieve healthy financial responsibility along with the power to gain and maintain wealth. This hands-on instructional program educates participants on the significance of maintaining a personal healthy financial lifestyle through self-help and peer-led techniques. The skills gained through this program will annihilate poverty, eliminate low credit scores, and introduce a healthy, wealthy money mindset to shift from simply surviving to thriving when it comes to finances.
