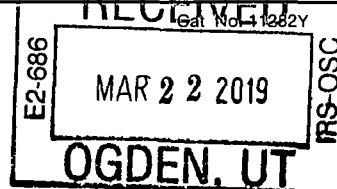

The organization's mission is to mobilize the local community to help the neediest among us by supporting and enhancing the community system of services, programs and facilities that work to prevent and end homelessness through fund raising and providing resources.

The organization provided a grant to the City of Virginia Beach Homeless Services and the Housing Resource Center to support the Prevention & Diversion Program within the City of Virginia Beach city limits. The Prevention & Diversion program is a multi-functional homeless assistance program. Homeless prevention and diversion includes short-term rental assistance up to \$3,000 per household, security deposits (up to 2 months); payment of rental arrears (up to 2 months); utility payments (up to 2 months), and case management. It is anticipated that the grant will be able to assist a minimum of 28 households (including those with children). The Housing Resource Center (HRC) provides the integration of shelter, housing, health center, dining hall, learning facility and community resources for homeless and at-risk families and individuals. The HRC provides 49 beds in a Singles Shelter, 10 motel-style units for short-term family housing, and 29 one-bedroom efficiency apartments used for affordable permanent housing. These funds will also assist those housed at the HRC.

4b (Code:) (Expenses \$ 14,000 including grants of \$ 14,000) (Revenue \$)

The organization provided a grant to the Virginia Beach Education Foundation primarily to be used to supply weekly "Beach Bags" during the 2019 school year to 133 students identified as homeless. Each Beach Bag contains 10 shelf-stable food items to provide students identified by School Social Workers and School Counselors as food-insecure with meals and healthy snacks to sustain them over weekends and during school breaks. By nourishing these most vulnerable students over weekends and breaks, they will return to school classrooms on Monday mornings alert and ready to succeed academically.

4c (Code:) (Expenses \$ 6,000 including grants of \$ 6,000) (Revenue \$)

The organization provided a grant to Virginia Supportive Housing (VSH) to provide tenant assistance for living expenses and supportive services for formally homeless individuals in two permanent supportive housing communities in Virginia Beach. These two facilities ensure that 105 formally homeless individuals have a high quality place to call home and a supportive services team for support to maintain stable housing. Specifically, VSH will provide \$200 per month per unit for tenant assistance for medications, groceries, laundry needs, healthcare co-pays and transportation.
