

Form 990, Part I, Line 1:

Immerse Arkansas has worked to assist runaway and homeless youth, especially older and former foster youth, in their transition to adulthood since 2013 as a program of Vine and Village (T.I.N. 27-1925096). Early in the program's history, the Executive Director created a separate corporation in anticipation of the program growing into a ministry of its own. Subsequently, it was decided that Immerse Arkansas would operate under a fictitious name of Vine and Village until its scope grew to the point where a separate entity was warranted. By mid-2016, it was determined that this point had been reached and the aforementioned corporation applied for, and was granted, non-profit status under its legal name of Immerse Arkansas.

While the intent was to transfer all current programming upon receipt of this status, this could not be done without jeopardizing an existing and substantial multi-year federal grant that was awarded in the name of Vine and Village. Efforts are still underway to effect this transfer, but as of the close of 2016, no such transfer had occurred. As a result, the only activity carried out by Immerse Arkansas has been the purchase and maintenance of a building which will be renovated in order to provide additional opportunities to support the youth being served, most notably, the establishment of a drop-in center to assist runaway and homeless youth who would not be in the organization's semi-supervise or scattered site housing. Once the grant can be transferred, all remaining programs will be assumed by this new corporation.

Form 990, Part III, Line 1:

Going forward, Immerse Arkansas will continue to renovate the building purchased this year in order to fully develop the drop-in center concept and develop new programs to support youth before and after their exit from foster care, such as creating programs to address issues of transition while youth are still in foster care.
