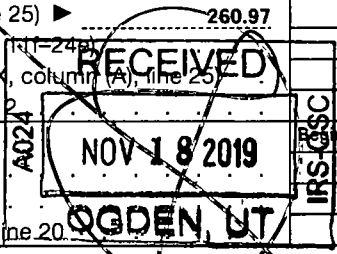

We cater toward low income and homeless individuals and families experiencing food insecurities. In this past fiscal year we shopped 2921 families containing 6015 family members fro 5 to 7 days of food. We averaged 6.13 tons of food monthly with an annual distribution of over 73 tons of food. We also offer peer support and referral to services for those inteested.
