AMENDED RETURN

The Form 990 is being amended for changes in the allocation of Program Expenses. There was a change in the Executive Director of Legacy after the return was filed. In reviewing the activity for the year, the new Executive Director discovered that many of the expenses of Legacy had not been correctly allocated. As a result of this review, the allocation between Program Expenses and Management & General Expenses was changed for Officer's Salaries, Other Salaries, Employee Benefits, Payroll Taxes, Accounting, Advertising, Office Expense, IT Expense, Occupancy Expenses, Conference & Meeting Expenses and Insurance Expense. These changes are shown in Columns B & C of Part IX of the Form 990. In addition, the change in Column B results in a change to amount shown on Line 4a of Part III of Form 990.

One other change made in this Amended return is the correction of an error in Schedule A, Section C. The tax program used did not calculate any Public Support Percentage for Lines 14 and 15. The Amended Return corrects this error by including the Public Support Percentage for each year.
