L4L's Primary Purpose is to identify Students (Elementary thru College) and US Veterans who have a need for a Laptop computer for school or employment, then provide them a device at an affordable cost or free of charge if the person's financial circumstance warrants.

During Fical Year 2019, L4L provided 82 laptops to students who sign on to our website. We have identified an additional 350 students who signed on to our 'Help-Fund-My-Laptop" app, who are actively seeking donations to allow them to purchase a computer device a that reduced cost of \$140 each. Additionally, we provided 50 laptops to a Veteran Support Agency at a matching cost discount of 50%. These are used by the agency to provide "Life and Job training skills" for US Vets in the Phoenix AZ area.
