What is the organization's primary exempt purpose?
 Our mission is to provide relevant training, resources and support to foster parents from a trauma-informed approach, giving them the skills and confidence to spark healing in vulnerable children. We hosted 38 trainings for foster parents, which hosted 1104 foster parents. We hosted 10 special events, provided 571 items, including 63 carseats, 149 weighted items, 74 mattresses and 48 beds and bunkbeds. We served 1995 children during this time. Wishes ranged from everything from strollers, cribs, car seats to sponsoring special needs like weighted blankets, specialized therapies, etc.
