In addition, during 2020, the Organization participated in a New Market Tax Credit financing transaction to secure the funding necessary to begin construction on the Market. As part of this transaction, the Organization contributed \$850,000 towards the project and donated land on which the Market will reside with a book value of \$41,500 to Greater Dayton Premier Management.
