Tree Giveaways The CSX Tree Giveaway provided 400 free fruit and native yard trees to residents of a low-income neighborhood with a low tree canopy in Delray Beach The area is home to multi-generational families of African-Americans, Haitians, Bahamians and other Islanders Even though fruit trees are highly valued both culturally and historically, they are often unaffordable On the day of the event, a diverse group of residents enjoyed telling tree memories of former fruit groves in the area, and the joy of teaching their children about the importance fruit trees in their culture Community Greening also hosted a tree giveaway at Grandview Public Market where 200 Florida native and fruit trees were distributed to residents of Palm Beach County

Public Parks The Arboretum at Constitution Park is the "tree zoo" of the City of Deerfield Beach. There are nine acres of land containing over 200 exotic trees from five continents around the world. On April 21, 2018 JM Family Enterprises, Community Greening and the Arbor Day Foundation went above and beyond to increase the city's tree canopy. This project mobilized 250 JM employees to plant 500 trees in three public parks in Deerfield Beach. In the city of Delray Beach, Community Greening planted more than 700 trees with 700 volunteers at six public parks.

Greenspace Transformation (1) TD Green Streets This project engaged 75 volunteers and added 100 trees to an empty 2 acre retention area in front of Spady Elementary School in Delray Beach's NW neighborhood. It was an ideal project to increase the tree canopy, engage school families and children, beautify a school, improve a bio-filtration basin and strengthen a pedestrian-friendly greenway. Lake Ida Road, where the lot is located, runs east-west through Delray Beach. The once barren water retention area is the "front yard" of a public elementary school and it was in serious need of beautification. Now there is increased shade along Lake Ida Road - a heavily-traveled road along a proposed greenway that connects Congress Avenue and the artful Pineapple Grove neighborhood. (2) TD Tree Days This project addressed the planting of 50 trees at an empty city lot in a low canopy neighborhood next to an interstate. The trees will create a low impact community green space, capture pollutants from the numerous cars traveling on I-95 and act as a sound buffer for the residents.

Neighborhoods Community Greening plants fruit and native shade trees for residents living in neighborhoods with low tree canopies. Including private property is essential when trying to increase the tree canopy from 20% to the recommended 35% - 40%. Community Greening distributes door hangers to announce the program, fields requests, provides onsite consultation for tree selection (including call before you dig), and plants the tree with residents and volunteers. Residents are given watering instructions and receive follow up calls about their tree's health.
