The HUB represents a network of agencies that provide evidence-focused care coordination and the professional work needed to identify and address risk factors. The HUB, as the quality center of the network, assures that care coordinators and programs collaborate in their approach to identify and address risk, reduce service duplication and increase the effectiveness of systems of care.
