Part III - Organization's Primary Exempt Purpose

The 1st Home Foundation (the "Foundation") will assist low-income individuals and families with transitioning from a rental residence to home ownership. The Foundation will acquire affordable, single family dwellings in safe neighborhoods, rehabilitate and make improvements to those dwellings, and seek individuals or families earning minimum wage or other hourly wage income to become tenants with the transition to ownership of the property after a specified length of time (to be determined on a case-by-case basis).

Tenants will be solicited with input from local charitable and religious organizations, as well as local public service agencies (i.e. Social Services) that have identified appropriate candidates that might benefit from the activities of the Foundation. Low-income individuals and families will be identified in accordance with the income limits computed and published by the Department of Housing and Urban Development ("HUD") in Income Limits for Low and Very Low-Income Families Under the Housing Act of 1937. "Low-income" is defined by the relevant housing statute as 80% of an area's median income.

Tenants must be able to satisfy the following conditions: (i) be able to manage a household, (ii) learn basic home ownership tasks, (iii) maintain the property during the rental term to acceptable standards, and (iv) make the necessary financial commitments to secure home ownership (i.e. mortgage, insurance, taxes, etc.).

Tenants must commit at the commencement of any rental period, to transition to ownership barring any unexpected circumstances. Tenants will pay rent during the transition period in an amount necessary to cover real estate taxes, insurance, any homeowners association dues, any community assessment costs, and repairs (excluding structural, roof and HVAC). Tenants will be responsible for paying the cost for any and all utilities. Any rent paid in excess of the above amount will be held by the Foundation to be credited towards the down payment on the purchase price of the home after the transition period. If a tenant does not purchase the home at the end of the transition period, any excess funds will not be returned to them, but will instead be used by the Foundation to purchase additional property.

After the rental transition period, the Foundation will assist the tenant in identifying lenders willing to provide financing to acquire the property. The Foundation will establish relationships with lenders or other organizations that coordinate with lenders, to assist tenants in obtaining financing. The purchase price for the homes will be the actual cost of the home plus the actual cost of any improvements made. Improvements will be made with the assistance of local contractors unrelated to the Foundation willing to perform the rehabilitation and improvements at their cost or other agreed upon price.
