From July 2019 - June 2020, Thrive Central Oregon held 3,623 meetings across Central Oregon, providing connections and referral to housing, health care, employment, entitlements and basic needs assistance to 2,137 unduplicated individuals. Over 6,735 services were provided program wide, including 4,477 links to permanent housing, affordable housing applications, Fair Housing law and eviction prevention.
