<p><b>28</b></p> <p>Compassion Delivered provides healthy meals to people coping with life-threatening or terminal illnesses here in our community at no cost to the person receiving them. In 2020 we provided 8,500 meals to people in our community who ranged in age from 10 years old to the late '90s. Not only do we get the opportunity to provide healthy meals to our clients but we get a chance to build a friendship with them and let them know they are not alone in this battle they are facing. This year's challenges with Covid-19 forced us to think outside the box and find additional ways to support the clients we serve. On top of the meals, we provided we also purchased meal kits that have the registered daily nutrition needed to have on hand in case we wouldn't be able to deliver to them due to lockdowns, etc. We also had the support of our community to provide blessing boxes with other essential items that people struggled to find. We are proud of the volunteers, donors, the board of directors, and support system we had this year to help navigate through the pandemic. We also engage children all over Stark Co. to decorate our delivery bags and write encouragement cards. These have become treasures to our clients because it represents that someone took time out of their day to do something for someone they will never have the chance to meet. In 2020 we planned to expand our men's support group and add a women's support group, though we can't meet in person we have started a small group that meets via zoom. The need for these support groups for men and women who have lost their wives, husbands, brothers, sons, daughters, sisters, partners, or friends. We believe our next step in our organization is to help those through the grief process. We are excited to look to the New Year where we will be able to help more people and our goal for 2020 is to provide 10,000 meals at no cost in our community.
