We launched the New Day Loan as an alternative to PayDay lending and lent out over 20 loans representing \$15,000. We worked with 20 emerging Black-led cooperative businesses as well as provided TA to local established cooperative businesses. We received approval of our CU application from the MN Department of Commerce as well as received verbal and financial support from the Mayor and City Council for this work. Over 25 local and national media outlets wrote articles for this work and we had 2 local news stations cover us for their evening news.
