Summer Engagement Program CISE students needed summer programs to prevent "summer slide". CISE provides an advocate at each elementary school to research and make available programs for students during the summer. Educational opportunities such as summer school and extra-curricular classes are available as are field trips, outdoor experiences, and arts programs. Power Packs Program Hunger is detrimental to learning. When CISE learned many of its students were coming to school on Monday hungry, they partnered with the Freestore Foodbank to provide Power Packs to food-insecure students. A Power Pack contains sufficient food for one child for the weekend. Each Friday during the school year, students, by teacher recommendation, receive a Power Pack. They no longer have to worry about being hungry over the weekend; they come to school fed and prepared to learn.

Part I, Line 2:	In carrying out its exempt purpose, CISE provides funding to each of the eight schools that it supports based on allocations that are determined by the CISE Finance Committee. The Finance Committee makes its determinations based on meetings with schools to understand their budgets and ascertain needs. In addition through the provision of scholarships and other financial support to CISE school graduates through the CISE High School Program, CISE will make grants and other distributions to Catholic high schools located within the Archdiocese. CISE keeps records of grants, grant applications, loan paperwork and specific details of other distributions in the form of meeting minutes. CISE requires an application for high school financial aid, but does not require a formal application for the eight elementary schools that it funds on an annual basis. CISE does have annual meetings with each elementary school where the Finance Committee/CISE Executive Director and school leadership review the schools' current budget projections for the next year, discuss financial needs, and accountability for use of the funds. CISE requires annual budget meetings between the CISE Finance Committee and leadership at the eight elementary schools. In addition, CISE has full-time staff members who monitor and support the CISE schools.
